Tom expressed gratitude to Denis Yaworski for his continuing hospitality in welcoming the Nutmeg Chapter members to the Haul of Fame for meetings as well as for exploration of the truck and heavy equipment collections. Denis did say that there were more trucks added to the collection. When asked about the appearance of the gray GMC, he simply stated that it just reappeared. On the sideboards of the dump body it says "Nutmeg Chapter ATHS". Members expressed their appreciation for hosting the annual meeting again this year.

Attendance: There were 50 signatures in the attendance book for this annual Thanks-Giving dinner meeting. Guests included Tim Walz' father and brother, his traveling buddies from Long Island and Betty Jay's sister-in-law.

A motion was made to accept this truck as recommended for the feature truck of the Brooklyn Show. The motion was seconded and the vote was unanimous for the 1966 C80 Chevy to be the featured truck.
- 4. Tom will notify Show Chairman John Raymond so that the photograph can be taken for the dash plaque, poster and tee shirts.

Harold Foskett has volunteered to host the January meeting at Foskett Equipment in Woodstock. The date is to be determined. (Editor Note: Later on in the meeting discussion, January 14, 2024 was the date selected).

From the past to the present: Harold Foskett acknowledged the veterans of the Nutmeg Chapter and recognized these long term members and leaders that created the Chapter and have kept it going for 41 years since the first show in September of 1982 in Bethany, CT. He spoke of shared memories of Al Newhouse, Bob West, Ken and Daisy Miller and how Charlie Dainton honored the Millers by keeping their Flea Market space open. He noted how Rob Coutu has written about the deep connection between God, country and the Nutmeg Chapter. Harold went on to praise Tom Bachand for his service as treasurer and for his leadership in the role of President, positions he has held both consecutively and simultaneously over a period of eight years. ATHS NATIONAL NEWS

For those of you who were not at our Annual Meeting, here is some of the latest happenings at National. After the Annual Meeting in Kansas City, it was announced by Marty Glomb, President of ATHS, that Laurence Gratiot, Executive Director, is no longer there. An interim Executive Director, John Gravley has been hired for about six months. His specialty is turning around nonprofits.

Charlie Dainton, our new President has spoken with Bill Wagner, the Regional VP for NJ, Eastern PA, Metro NY. Bill gave us permission to publish his report of the Annual Board of Directors meeting that was listed in the ATHS Long Island December Newsletter issue of Tired Iron:

I have returned from the ATHS Board of Directors meeting and want to update you all on several items. I have agreed to stay on for another year. There have been many changes, and I was asked to assist all with my limited experience.

Many of you are aware that I butted heads with Laurence more than once and felt the east coast locations were not always receiving good advice. I want to advise you all that Laurence Gration is no longer an employee of the American Truck Historical Society.

The treasurer resigned a short time ago, and the executive committee was asking questions about the convention and our money accounts. The books have received an audit, and the monies accounted for, but not quite the way expected.

It seems Laurence had authorized spending totally different from the executive committee's plan. The short story is, he has committed us to projects that were planned in the future when money was available.

The profits from the previous Reno convention were in excess of \$100,000, this year we broke even at best, as there are still bills to be paid. The full board voted for both the removal, and the financial plan to save our reputation and get back to proper business programs.

The new treasurer is Craig Vogel a very dedicated member from the State of Washington. He has already asked me to be on the finance committee. His plan is to simplify the financial reports so they can be read and understood by all.

The only long term employee left on staff is Courtney Cesar our library director, she has had to cover a lot of turf, really looking forward to her getting more library time. Brad Patterson is working with membership, chapters, and volunteers. I have had good experiences with him so far and think you all will enjoy his enthusiasm. Brandy Cavallaro is the new bookkeeper and a joy to work with. Darin Burt is the new editor of Wheels of Time, Show Time and The Dispatch. He actually assembled the lastest issue rather quickly after Aaron left. Marina Spexarth is still with us as our Communications & Marketing person.

(Bill goes on to state that he is available to assist the chapters he represents and reminds them of the year end reports)

Since we do not have our own Regional VP, we thank Bill Wagner for sharing this information with us. In speaking with Brad Patterson the new Membership, Chapters and Volunteers person, he told me they are working with a skeleton crew. The new web-site has some problems along with the new phone system.

In a Zoom Meeting on November 28, it was brought up that National really needs e-mail addresses so they can send announcements to members thus saving the cost of postage. There is a need for more Regional VP's. Some of the current RVP's are taking on additional states. They hope to have the web-site up and running soon. They are hopeful that the decline in membership has bottomed out. In a future issue of WOT, they are going to promote the various scholarships that are available to members. RVP B.J. King brought up the fact that to obtain an insurance certificate from the insurance company for a Chapter Show costs around \$175. (Brooklyn Fairgrounds requires that we have this insurance, as do most venues.) Last year National spent \$15,000 on these insurance certificates. He said that insurance for a truck show would cost a Chapter about \$1,000, if they were able to get it. He said the Chapters that he is RVP for said they are willing to pay \$200 for the insurance certificate to ease the money crunch.

The Chapter Annual Reports needs to be filed by January 31, 2024. You can mail a hard copy or e-mail a PDF version. National needs this information to satisfy our non-profit status with the IRS. Remarkably, last year 100% of the Chapters had this information in by the deadline.
